SUBJECT: Management Structure for actions under Implementation Plan for Defense Nuclear Facilities Safety Board (Board) Recommendation 2000-2, *Configuration Management, Vital Safety Systems*.

As the Responsible Manager for the Implementation Plan for Board Recommendation 2000-2, I am responsible for organizing and coordinating the Department's actions in response to the Recommendation.
